Mississippi Public Education Progress 2013 to 2023



Learning: \$35.1 million

On-Demand Tutoring: 350,000 students in grades 3-12 in 142 districts and two charter schools have access to online tutoring in English Language Arts and mathematics 24 hours a day, seven days a week. Students have also participated in science and history sessions.

- Professional development provided to approximately 31,000 teachers and 6,500 administrators
- Students participated in 409,308 live sessions with tutors
- 173,856 essays were submitted for review

College and Career Readiness: 131 districts have implemented the computer platform to manage college and career readiness goals and automate the Individual Success Plans (ISPs) for students in grades 7-12

 79,912 currently enrolled students have initiated ISPs, an increase of 24,281 students since the previous school year

Safety: \$14 million

135 districts use this unified school safety platform to enhance and strengthen their emergency operation plans, collaborate with first responders on faster emergency responses that provide clearer directions and location of emergency events, and use cameras to detect and mitigate potential threats or contraband on campus.

- 2,200+ cameras installed
- 89 million square feet mapped in more than 780 buildings
- 2,400 staff trained in 83 districts





Mississippi Teacher Residency: \$9.8 million

Funds cover tuition and expenses for **up to 200 candidates** seeking a graduate degree in elementary and secondary education at Delta State University, Jackson State University, Mississippi State University, University of Southern Mississippi and William Carey University.



Licensure Call Center & New Licensure System: \$6.9 million

Funds expanded hours, **increased staff from four to 15** and developed new licensing system, Mississippi Educator Career Continuum Archive (MECCA). MECCA's Educator Preparation, Licensure, and Misconduct Evaluations function launched in January 2023. Functions for accreditation monitoring and educator recruitment and evaluation will launch before September 2024.





Telehealth: \$17.6 million

Through partnership with University of Mississippi Medical Center, telehealth services implemented in 73 districts and 421 schools. Students can access urgent care and behavioral health services at their school.



MSIS 2.0: \$12.7 million

Funds will modernize Mississippi Student Information System (MSIS) by summer 2024.













3rd Grade Reading Achievement


Initial vs. Final Pass Rates 2019–2023





Secondary Education

- Expanded the implementation of career academies by providing school/district leaders one-on-one coaching, personalized professional development, and initial reviews for program efficacy. (Goals 1, 2)
- Implemented policies, statewide communication, and technical supports to expand student opportunities to dual credit/dual enrollment, Advanced Placement (AP), International Baccalaureate (IB), and Cambridge Advanced International Certificate of Education (AICE) courses, and Science, Technology, Engineering and Mathematics (STEM) pathways. Career and Technical Education

- Expanded opportunities for students to acquire postsecondary industry credentials that are recognized by local business and industry. Mississippi schools now offer 43 industry credentials representing eight of the national career clusters. (Goal 2)

- Promoted the acquisition of work-ready skills through the ACT WorkKeys assessment to over 23,133 distinct students with 65.8% scoring at the silver level of higher. (Goal 2)













Mississippi's Dropout Rate











Participation & Achievement More than Doubled 2013-2023






ACT WorkKeys

State funds provided for ACT WorkKeys testing starting in 2021–22






Pre-K Students Scoring

Kindergarten readiness among Early Learning Collaborative students rose from 59% in 2015 to 64.8% in 2023




Kindergarten Readiness & Growth

Fall Pre-Test vs. Spring Post-Test 2021–22 & 2022–23







Educator Licensure and Information System

- Launched the Educator Preparation, Licensure, and Misconduct Portal and piloted the Educator Effectiveness Portal within the Mississippi Educator Career Continuum Archive (MECCA) to initiate a comprehensive educator workforce information system. (Goals 1-6)

 - Average licensure application processing days: 1.4 days





MSIS Modernization

- Completed infrastructure for MSIS 2.0 (part of modernization phase 2); development of data collection and reporting progressing towards July 2024 launch. (Goal 5)

Data Privacy, Security and Systems
