<u>Scope of Project</u>: The purpose of this contract is to retain the services of American Institutes for Research to serve as an independent contractor who will administer Alternate Assessments for English Language Arts (ELA) and Mathematics for Grades 3-8, Science for Grades 5 & 8 and High School Algebra I, English II and Biology for Students with Significant Cognitive Disabilities. The Individuals with Disabilities Education Act (IDEA) Section 300.160.C and No Child Left Behind (NCLB) both require an alternate assessment be provided based on alternate achievement standards for students with Significant Cognitive Disabilities (SCD) who by nature of their disability cannot access the general education standards. The contract services will include, but not be limited to, the following:

- Test Administration
- Enhancement of Test Content
- Professional Development & Standard Setting
- Test Development & Item Authoring

Renewal of contract for years two through ten will be determined annually and shall be contingent upon the successful completion of the preceding year's contract and the availability of funds. Personnel associated with this contract are not former Department employees or related to any Department employees.
