 J. <u>Approval to establish Process Standard 32 – Youth Detention Centers of the</u> <u>Mississippi Public School Accountability Standards, 2014</u> [Goals 2 and 4 – MDE Strategic Plan] (Has cleared the Administrative Procedures Act process with no public comments)

On April 14, 2015, the Commission on School Accreditation approved the establishment of Process Standards 32 – *Youth Detention Centers*, of the *Mississippi Public School Accountability Standards, 2014.* 

The Office of Compulsory School Attendance presented the rationale for establishing Process Standard 32, *Youth Detention Centers*, to the Commission on School Accreditation for approval.

Process Standard 32 provides statutory and State Board of Education requirements for educating juveniles in youth detention centers. It also provides the financial reimbursement guidelines for the non-sponsoring school districts.
