E. <u>Approval to award discretionary Educator in Residence grants to school districts</u> for literacy coaches

<u>Purpose</u>: To extend the reach of the Mississippi Department of Education (MDE) to provide practitioner expertise, technical assistance, and capacity building across the state in the area of literacy in accordance with the Literacy-Based Promotion Act.

Discretionary grants will be awarded to school districts in support of the Educator in Residence program through which services of the MDE to local school districts will be enhanced. These grants will place an additional 5 literacy coaches in literacy target schools across the state. Literacy target schools are identified for coaching support based on a two-year average of the percentage of 3rd grade students scoring below proficient on the statewide assessment.

Literacy coach support will include, but is not limited to: providing daily technical support to school-based coaches or lead teachers in their capacity to support instruction of the 5 components of reading, implement curriculum, administer assessments, analyze data, and utilize technology; modeling, effective coaching and conferencing techniques; and assisting administrators, school-based literacy coaches, and teachers in addressing grade specific curriculum by developing an effective school-wide literacy plan and providing strategies for monitoring the plan's implementation.
