Executive Summary

Pathway Description

The Broadcast Foundations course is a one-credit offering within the Multimedia pathway that provides a comprehensive introduction to the broadcasting industry, emphasizing practical skills and understanding of media's evolution. Students learn the intricacies of scriptwriting, the nuances of on-air performance, and the technical aspects of television editing and studio control. With an emphasis on safety, leadership, and legal compliance, this pathway prepares students for the demands of the field, blending theoretical knowledge with hands-on experience to ensure they are well-equipped for various roles in broadcasting and media production.

Grade Level and Class Size Recommendations

It is recommended that students enter this program as sophomore. Exceptions to this are a district-level decision based on class size, enrollment numbers, student maturity, and CTE delivery method. This is a hands-on, lab- or shop-based course. Therefore, a maximum of 15 students is recommended per class with only one class with the teacher at a time.

Student Prerequisites

For students to experience success in the program, the following student prerequisites are suggested:

- 1. C or higher in English (the previous year)
- 2. C or higher in high school-level math (last course taken or the instructor can specify the level of math instruction needed)
- 3. Instructor approval and Test of Adult Basic Education (TABE) reading score (eighth grade or higher)

- 1. TABE reading and math score (eighth grade or higher)
- 2. Instructor approval

or

1. Instructor approval

Career Pathway Outlook

Overview

The Broadcast Foundation course, integral to the arts, A/V technology, and communications cluster, offers applied instruction aligning with Mississippi's community and junior college programs. It emphasizes foundational design and creativity, leveraging diverse platforms for artistic expression. This course nurtures essential 21st-century design skills and digital citizenship. Geared towards careers in broadcasting, graphic design, media, and more, it includes layout creation, product illustration, and software training in CAD and desktop publishing. This pathway prepares students for advanced courses like digital design and video production, leading to opportunities in advertising, publishing, motion picture, and design services. It also positions students well for associate degrees and higher education, catering to careers ranging from technical writing to executive roles in multimedia-related fields.

Needs of the Future Workforce

The U.S. Bureau of Labor Statistics forecasts a steady growth in arts and design occupations from 2022 to 2032, mirroring the average across all fields. Annually, approximately 95,800 new openings are expected due to growth and turnover. As of May 2022, the average wage in these fields was \$51,150, surpassing the median for all jobs. In 2021, the majority of fine and performing arts graduates specialized in commercial art, graphic design, and fine arts. A significant 64% of these graduates found roles in related fields. Notably, in Mississippi, graphic design ranks third in employment within this cluster. Art director roles, needing a bachelor's degree, are projected to grow by 6% from 2022 to 2023, outpacing graphic designers and managers at 3%. High-earning positions like art directors, special effects artists, and animators average around \$100,000 nationally, while fashion and industrial designers earn about \$75,000, and interior and graphic designers approximately \$60,000. Best Practices

Innovative Instructional Technologies

Classrooms should be equipped with tools that will teach today's digital learners through applicable and modern practices. The Broadcast Foundations educator's goal should be to include teaching strategies that incorporate current technology. To make use of the latest online communication tools—wikis, blogs, podcasts, and social media platforms, for example—the classroom teacher is encouraged to use a learning management system that introduces students to education in an online environment and places more of the responsibility of learning on the student.

Differentiated Instruction

Students learn in a variety of ways, and numerous factors—students' background, emotional health, and circumstances, for example—create unique learners. By providing various teaching and assessment strategies, students with various learning preferences can have more opportunities to succeed.

CTE Student Organizations

Teachers should investigate opportunities to sponsor a student organization. There are several here in Mississippi that will foster the types of learning expected from the Broadcast Foundations curriculum. SkillsUSA, TSA, MECA and FBLA are examples of student organizations. Student organizations provide participants and members with growth opportunities and competitive events. They also open the doors to the world of multimedia careers and scholarship opportunities.

Cooperative Learning

Cooperative learning can help students understand topics when independent learning cannot. Therefore, you will see several opportunities in the Broadcast Foundations curriculum for group work. To function in today's workforce, students need to be able to work collaboratively with others and solve problems without excessive conflict. The Broadcast Foundations curriculum provides opportunities for students to work together and help each other complete complex tasks. There are many field experiences within the Broadcast Foundations curriculum that will allow and encourage collaboration with professionals currently in the multimedia field.

Work-Based Learning

Work-based learning is an extension of understanding competencies taught in the Broadcast Foundations classroom. This curriculum is designed in a way that necessitates active involvement by the students in the community around them and the global environment. These real-world connections and applications link all types of students to knowledge, skills, and professional dispositions. Work-based learning should encompass ongoing and increasingly more complex involvement with local companies and multimedia industry professionals. Thus, supervised collaboration and immersion into the multimedia industry around the students are keys to students' success, knowledge, and skills development.

Unit 1: Orientation, Safety, and Leadership

 - j. Identify and apply the ABCs of CPR.

Note: Safety is to be taught as an ongoing part of the program. Students are required to complete a written safety test with 100% accuracy before entering the shop for lab simulations and projects. This test should be documented in each student's file.

Note: This unit will be ongoing throughout the year. Time allotted for this unit will be distributed over the entire year.

 - a. Discuss the history and evolution of the television production and broadcasting industry.
 - b. Analyze the progression and emerging trends in the television industry, with an emphasis on understanding its past, present, and future dynamics.
- 2. Compare and contrast the components of the broadcasting industry. DOK 2
 - a. Explain, compare, and contrast different program types and their production processes.
 - b. Explore various news sources, including digital, television (local and national), streaming services, and nontraditional methods.
 - c. Identify and describe various career paths within the television production industry.



Unit 3: Scriptwriting for Broadcast

- 1. Demonstrate the ability to write for television productions. ^{DOK 2}
 - a. Explain the significance of the five W's (Who, What, When, Where, Why) and one H (How) in news reporting.
 - b. Demonstrate the craft of creating a compelling lead for a news story.
 - c. Describe the structure of the inverted pyramid style in journalism.
 - d. Demonstrate how to construct an effective story headline.
 - e. Analyze the distinctions between national, world, and local news coverage.
- 2. Demonstrate the ability to write audio and television production scripts. DOK 2
 - a. Analyze professional audio and television broadcasting scripts, including the use of rundowns.
 - b. Conduct research on a chosen subject for scriptwriting purposes.
 - c. Identify the target audience for a given broadcast script.
 - d. Use language that is appropriate for the identified audience and type of production.
 - e. Assemble audio cues, video cues, and dialogue into a rough script draft.
 - f. Revise the script to fit time constraints and format requirements.
 - g. Edit the script to correct mechanical, grammatical, and usage errors.
 - h. Write complete scripts for various types of productions, such as newscasts, talk shows, sports shows, interviews, commercials (30 seconds and 60 seconds), and public service announcements (30 seconds and 60 seconds).



Unit 4: Broadcast Performance

- 1. Discuss and demonstrate the use of advanced oral communication skills in broadcast performance. ^{DOK 2}
 - a. Examine the importance of clear and articulate speech for on-camera performance.
 - b. Explore the elements of effective communication, including body language and posture.
 - c. Employ oral communication techniques such as proper cadence and word choice to enhance delivery.
 - d. Analyze various speaking styles on camera, emphasizing articulation, delivery, transitioning, and the development of a unique speaking style for personal branding.
- 2. Produce broadcast segments that showcase professional communication techniques. DOK 3
 - a. Create a talk show segment that demonstrates engaging and dynamic hosting skills.
 - b. Organize a debate segment focusing on the clear articulation of arguments and rebuttals.
 - c. Discuss and present a 'hot topic' segment, highlighting the ability to handle current and sensitive issues with appropriate tone and delivery.
- 3. Analyze and refine on-camera performance. DOK 3
 - a. Critique broadcast performances, focusing on aspects such as cadence, word choice, and the use of catchphrases.
 - b. Develop and refine a unique on-air presence that aligns with broadcast branding and audience engagement.
- 4. Compare and contrast the requirements of effective communication techniques across different media platforms. ^{DOK 3}
 - a. Evaluate how body language and posture must be adapted for various mediums, such as television, radio, and online streaming.
 - b. Assess the differences in speech and presentation style required for diverse formats and contexts.



Unit 5: Television Editing

Competencies and Suggested Objectives

- 1. Explain the purpose and fundamentals of editing for television broadcasts. DOK 2
 - a. Identify and define key editing terms and their significance in the editing process.
 - b. Discuss the objectives of editing in shaping the narrative and flow of a video file.
 - c. Recognize the various tools and software used in the television editing process.
- 2. Demonstrate proficiency in operating nonlinear television editing equipment. DOK 2
 - a. Familiarize with the components of a nonlinear editing system.

b. Execute basic to advanced video editing techniques using a nonlinear editing system.

- 3. Apply audio editing techniques to enhance broadcast quality. DOK 2
 - a. Create and manipulate graphic elements to complement video content.
 - b. Utilize audio editing tools to correct and enhance soundtracks for television.
- 4. Integrate graphics effectively into television broadcasts. DOK 2
 - a. Identify and define key editing terms and their significance in the editing process.
 - b. Apply graphics and visual effects to support and enhance the storytelling in broadcasts.



Unit 6: Studio/Control Room Equipment

 - a. Identify the functions of studio cameras, camera control units, teleprompters, video switchers, character generators, and studio intercom systems.
 - b. Identify the different types of lighting for television production.
 - c. Operate studio cameras, camera control units, teleprompters, video switchers, character generators, and studio intercom systems.
 - d. Demonstrate appropriate lighting for television studio productions and field productions.
- 2. Demonstrate the ability to operate audio control room equipment. DOK 2
 - a. Identify the functions of an audio control console, microphone mixer, and waveform monitor.
 - b. Operate an audio control console, microphone mixer, and waveform monitor.
 - c. Identify the various microphones used in television broadcasting and production.
 - d. Demonstrate how to use various microphones.
 - e. Apply the techniques of a beginning audio control operator.
- 3. Demonstrate the procedures for directing television productions. ^{DOK 2}
 - a. Understand the role and responsibilities of a television director.
 - b. Direct a rehearsal, coordinating the crew and talent to prepare for live or recorded productions.
 - c. Implement the use of hand signals and verbal cues to manage a live broadcast effectively.
 - d. Practice directing segments to become proficient in live program execution.
- 4. Incorporate artificial intelligence (AI) in broadcasting operations. DOK 2
