## **DIVISION OF EDUCATOR PREPARATION**

W. Approval of Mississippi State University's request to modify its existing licensure-track supplemental endorsement in the area of Special Education Mild/Moderate

Disabilities (K-8) by adding equivalent graduate level coursework to allow candidates to complete eighteen (18) hours of undergraduate level coursework or graduate level coursework or a combination thereof for obtaining the supplemental endorsement

<u>Background Information</u>: In accordance with Miss. Code Ann. § 37-3-2 there is established within the MDE the Commission on Teacher and Administrator Education, Certification and Licensure and Development. It shall be the purpose and duty of the commission to make recommendations to the Mississippi Board of Education regarding standards for the certification and licensure and continuing professional development of those who teach or perform tasks of an educational nature in the public schools of Mississippi.

On July 12, 2024, the Commission on Teacher and Administrator Education, Certification, and Licensure and Development (Licensure Commission) granted approval of a request received from the Division of Educator Preparation that would allow Mississippi State University to modify its existing Special Education Mild/Moderate Disabilities (K-8), licensure code 223, supplemental endorsement licensure pathway by adding equivalent coursework at the graduate level to allow candidates to complete eighteen (18) hours of undergraduate level coursework or graduate level coursework as outlined herein. This supplemental endorsement shall be added to Elementary Education (K-3), (K-4), (K-6), and (4-6) licenses only. This supplemental endorsement requires passing scores on the Foundations of Reading assessment.
