#### **OFFICE OF HEALTHY SCHOOLS**

04.B. Action: Approval of grant awards for the School Nurse Intervention Grants, as identified in the Mary Kirkpatrick-Haskell, Mary Sprayberry School Nurse Program, Miss. Code Ann. § 37-14-3 and funded by legislative appropriation [Goals 1, 2, 3, 4, 5, and 6 of MBE Strategic Plan]

Background and Purpose: In 2007 the Mississippi Legislature created the Mary-Kirkpatrick-Haskell, Mary Sprayberry Act, Public School Nurse Program, Miss. Code Ann. § 37-14-3. The program receives an annual legislative appropriation for the purpose of continued support for the School Nurse Intervention Program. The Office of Healthy Schools will award seventy-two (72) grants based on successful competitive grant applications. Any school district may apply for and receive up to two grant awards. The grant funds of \$42,500 for each grant are distributed each year with up to four annual extensions based on legislative appropriation and completion of grant requirements. Annual mandates include budget and school nurse program narratives.

#### Scope of Grant:

• Grant Period: August 1, 2019 – June 30, 2020

• Award Amount: \$3,060,000

Method of Award: Competitive Application

<u>Funding Source</u>: State General Funds House Bill 1649, 2019 Legislative Session. Transferred from the Mississippi State Department of Health via a memorandum of understanding.
