CORRECTION TO BID RECEIPTS

The Mississippi Department of Education (the MDE) released Bid No. 18-2150-P407 entitled "Direct to Manufacturer" on August 22, 2018. Bid responses were due by 10:00 A.M. on September 27, 2018, with the public bid opening to take place at 11:00 A.M. on that date.
