New Items Added To The Order Guide



Breakfast Pizza (#1119) Whole Wheat Breakfast Flatbread, Nardones replaces the breakfast boat. One 2.47 oz. 3x5 whole wheat breakfast flatbread provides 1 oz. equivalent MMA and 1 oz. equivalent of grains. Flat bread contains egg, sausage, bacon, and cheese. Packed 80/2.47 oz. portions per case. This product is in stock and ready to ship!

RF Doritos, White Nacho Tortilla Chips (Item#2607), Frito Lay Each 1 oz. bag is equivalent to 1.5 oz. of grain. Whole Grain Rich. Smart Snack compliant. Packed 72 per case



Munchies Munch Mix Snack Mix (Item #2119), Frito Lay Each 0.875 oz. bag will provide 1 oz. equivalent grain. Smart snack compliant. Packed 104 per case.





Food Distribution Advisory Committee (FDAC) Vacancies

We wish Mary Hill of Jackson Public Schools the very best as she enters into retirement. We also wish Ed Hill of West Bolivar Schools success in his new food service venture in the private sector. With these directors leaving, two committee seats are vacant. Nominees must be School Food Service Administrators serving in Regions 1 or 5. Nominations may be emailed to dstubbs@mdek12.org until August 30, 2019. SFSA's may nominate themselves or another SFSA from the region you or they serve in. The remaining Region 1 term expires December 2021, and the Region 5 term will renew and expires December 2022.

Serving on the State Purchasing PMC and FDAC during the same timeframes is not allowed. FDAC meetings are held by conference call. Annually a survey of available USDA foods is emailed for consideration for the upcoming school year. It is rare to have face to face meetings, however if one is required, travel expenses will be reimbursed according to State of Mississippi and MDE travel reimbursement guidelines. Duties are, but not limited to, soliciting input from organizations within your region by phone or email regarding the quality and acceptance of USDA Foods received, and input offered for the next school year.

- 1. Committee compiles items to be placed on the MDE, Food Distribution website for the annual survey for requested USDA Foods.
- 2. Determines yearly FFAVORS budget.
- 3. Determines MS Grown DoD items to be offered.
