We have some great products available for you beginning July 1st that we think you, your staff and most importantly your students will enjoy feasting on!



Ciabatta Bread (Item# 1208): *Pillsbury*- Replaces the flat-out bread. Pre-sliced. One pre-sliced Ciabatta equals one sandwich. Ciabatta bread provides 2 oz. WG grain equivalent for the CN Meal Pattern Requirements. Packed 96/1.80 oz.

Nacho Bites (Item# 1109): Father's Table. - A blend of three cheeses and refried beans in an oven able, crispy Whole Grain Rich corn Masa crust. 8 bites provides 2 M/MA and 2oz eq WG's. Packed 72 servings per case.
