Other Business

1. Dr. Neal reported on certification hearings since the last Commission meeting:

On January 8, 2015, the Commission's Hearing Subcommittee comprised of Pamela Manners, Brian Pearse, and Cindy Melton held three licensure hearings:

- The Commission granted a continuance to educator Scott Minchew, License number 161708, after he and his counsel made an appearance and requested the continuance.
- The Commission revoked the following licenses for one year due to violations of Standard Four of the MS Educator Code of Ethics
  - o License 181602 held by Christopher Carlisle
  - o License 224250 held by Chad Hunt

On January 9. 2015, the Commission's Hearing Subcommittee comprised of Pamela Manners, Liz Michael, and Debra Mays-Jackson held two licensure hearings.

- The Commission granted a continuance to educator Revis Fortune, License number 219042, as he was deployed.
- The Commission decided not to process application number 170391 submitted by Bobby Coleman.

On February 12, 2015, the Commission's Hearing Subcommittee comprised of Pamela Manners, Liz Michael, and Kelly Fuller held two licensure hearings:

- License application 224409, a felony applicant, submitted by Dewan Ashford, was approved
  for processing by the Commission, after submitting court documents and testifying to his
  ability to perform the duties of a license.
- It was the unanimous decision of the Commission's Hearing Subcommittee to take no action on license number 161708 held by Scott Minchew who was charged with a violation of Standard Four of the Code of Ethics.
- 2. Dr. Neal announced that as of February The Office of Educator Licensure no longer approves educator licensure applications for individuals seeking certification via international reciprocity. The MS Department of Education will honor all current, valid MS licenses obtained through international reciprocity prior to this date. However, all who request renewal of such license must meet current certification requirements at that time.
