VII. Mississippi Department of Education (MDE) Updates (Dr. Cory Murphy)

Dr. Cory Murphy wished the Commission members are Happy New Year and expressed his thanks to the Commission members for their commitment to advocating on behalf of education stakeholders across the state and for serving as a voice for the children of the state of Mississippi.

Dr. Murphy reported that MDE was notified in the last quarter of 2019 by the Mississippi Community College Foundation Board members voted to suspend the administration of two alternate route programs: MAPQT (Mississippi Alternate Path to Quality Teachers) and MAPQSL (Mississippi Alternate Path to Quality School Leadership). MDE is working with Dr. Nettles to assure that candidates who are currently enrolled in these program are not adversely affected.

Dr. Murphy also noted that the MAPQT and the educator track of the MAPQSL program are State Board approved pathways. There is a Business track that is required by law in statute 37-3-2(7d) and one criterion for candidates is the completion of a training program, this need was previously met through the MAPQSL program. A subcommittee will be convened to address what pathway will be offered to to replace MAPQT/MAPQSL for this particular license.

Dr. Murphy also stated that it had been requested that upcoming events and conferences be shared with the Licensure Commission and had the following to report:

The Annual Mississippi Administrator and Teacher of the Year ceremony is scheduled for Friday, March 27, 2020 at 11:00 AM at the Jackson Convention Center.

The Third Annual Elevate Teachers Conference will be held in July 2020

Dr. Murphy also reported that ETS had previously notified states that they would be discontinuing the Praxis Elementary Education subject assessment that is used for non-traditional/alternate route candidates who are seeking certification in grades 4-6 through

the MAT program, however after receiving feedback from the states, ETS has decided to continue the use of the assessment and no changes will be need to be made at this time.
