This RAR process is designed to:

- Identify whether a school has been shortchanged financially relative to its peers, and whether changes in district allocation could help.
- Help LEA and school leaders make the connection between dollars and student outcomes.
- Generate discussions between leaders at the LEA and at the school to uncover opportunities and obstacles to more strategic resource use to improve student outcomes.
- Tap existing data and coordinate with other existing requirements to reduce burden.



RAR discussion protocol (~ 90 minutes)

1. Answer any <u>questions on the data provided</u>

- LEA and school leader(s) ask questions. [5 minutes]
- SEA responds where feasible and acknowledges where necessary that data may not capture all relevant context. [5 minutes]
- 2. LEA briefly describes the LEA's current resource allocation methodology
 - LEA describes the methodology. [5 minutes]
 - SEA and school leader(s) are invited to ask clarifying questions. [3 minutes]
 - LEA responds. [2 minutes]

An allocation methodology might be a staffing formula, a weighted student formula, a combo, etc.

- 3. LEA and school leader(s) to reflect on the level of dollar resources allocated to the school
 - School leader(s) offers any reactions. [5 minutes]
 - LEA reflects and responds. [5 minutes]



Discussion protocol continued...


- 4. SEA invites <u>reflection on how to better leverage resources to do more for students</u> (including changing the mix of resources, identifying barriers, etc.).
 - School leader(s) reflect. [10 minutes]
 - LEA reflects and responds. [10 minutes]
 - School leader(s) respond. [5 minutes]

5. SEA invites discussion of possible opportunities and barriers.

- SEA recites back any possible opportunities identified by LEA or school leader(s) for change and acknowledges any barriers in place. [5 minutes]
- School leader(s) react and reflect. [5 minutes]
- LEA reflects and responds. [5 minutes]
- 6. LEA and school leader(s) reflect on discussion and identify next steps.
 - LEA reflects on the discussion and offers any other thoughts or next steps. [5 minutes]
 - School leader(s) reflect on the discussion and offer any other thoughts or next steps. [5 minutes]
 - SEA summarizes responses with next steps. [5 minutes]




Introducing Data Visualizations



Data visualizations for resource allocation reviews

Array: Per-Pupil Spending by School

 Identify if a school has been shortchanged relative to its peers, and whether changes in district allocation could help.



Scatterplots: Per-Pupil Spending vs Outcomes by School

- Help LEA and school leaders connect resource allocation to student outcomes.
- Generate high-quality discussions between leaders at the LEA and school to uncover opportunities and obstacles to more strategic resource use to improve student performance.
- Create urgency for leveraging resources to do more for students.

Both visualizations: Minimize the burden by tapping existing data and coordinating with other existing requirements.










District Spending by School vs. School Outcomes






District Spending by School vs. School Outcomes





District Spending by School vs. Graduation Rates






District Spending by School vs. Outcomes
