CSI Schools Annual Interview

- ❑ The Interview will be facilitated from district lens
- ❑ Only CSI schools will be interviewed
- ❑ Interviews will be virtual
 - ✓ Conducted *November 17-18, 2020*
- ❑ 19 Districts
 - ✓ 35 Schools

Process Overview

- ⌘ **Who**: Select 1-2 members from your district team to deliver the presentation
- ⌘ **What**: Deliver a presentation that provides a narrative of the district's current status focused on the topics presented in the template and probable next steps
- ⌘ **When**: Presentations must be submitted to MCAPS no later than **November 13, 2020**
Interviews will take place Tuesday, November 17 - Wednesday, November 18, 2020
- ⌘ **How**: Each school will receive a pre-scheduled time to present within a 60-minute block, which includes 30 minutes for Q&A (***districts with 3 or more schools will be allotted additional time to present***)
- ⌘ **Where**: Teams will present virtually – A Teams Link will be emailed to district personnel (Superintendent and School Improvement Facilitator)

PowerPoint Guidelines

- ⌘ **A PowerPoint template has been created for district presentations. Districts must use the template as provided.**
 - Districts should not add photos, change the color, or the font
 - The only portion of the template may be customized is the content, which should be provided in sentences, bulleted concepts, tables, charts or graphs
 - PowerPoint slide limit is **22 slides**, not including the “*Title*” or “*Questions From State Team*” slide
 - Presentation length is **30 minutes unless otherwise determined based on number of CSI Schools**
 - Font may be no smaller than 18pt.

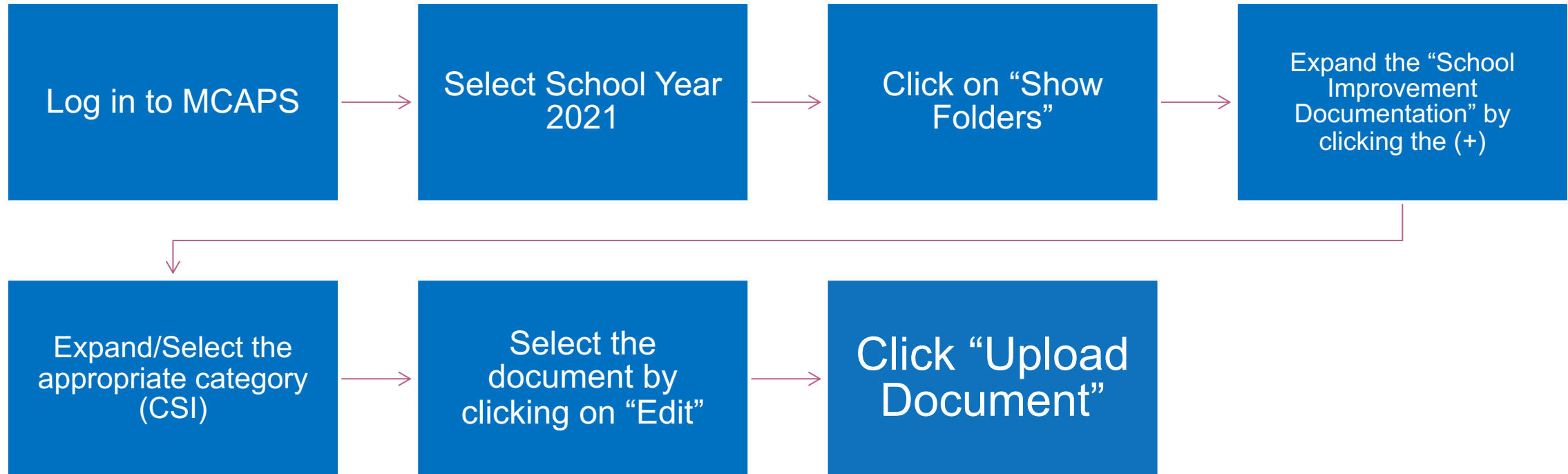
