UNDERSTANDING THE MISSISSIPPI ACCOUNTABILITY SYSTEM FOR GRADING SCHOOLS AND DISTRICTS

Overview of Accountability System and How it Got Started

Mississippi's schools and districts are graded annually on an A-F scale. These grades are part of the state's accountability system, which helps teachers, school leaders, parents and communities know how well their local schools and districts are serving their students.

Mississippi's school grading system considers several indicators, including how well students perform on state tests, whether students are showing improvement on those tests from year to year and whether students are graduating within four years. The system also factors in how well schools are helping English learners and their lowest-achieving students make progress toward proficiency.

The federal government requires all states to develop a system to annually evaluate the performance of public schools to ensure all students are being provided equitable access to a quality education. The Mississippi Legislature passed *legislation* in 2013 requiring the state to implement a single A-F grading system that meets state and federal requirements. The law requires grades to be based on student achievement and growth on state assessments, with an emphasis on the progress of the lowest performing 25% of students, and the percentage of students graduating within four years.

Since the 2013 accountability system law was enacted, legislators, superintendents, administrators, Mississippi Department of Education officials, and business and policy leaders have remained involved in developing and refining the accountability system.

What Specific Factors are Included in Accountability Letter Grades?

- Student performance in math and English Language Arts on state assessments in grades 3-8 and in high school Algebra I and English II
- Whether all students are meeting annual expected growth in math and English Language Arts
- Whether the lowest performing 25% of students are meeting annual expected growth in math and English Language Arts
- Student performance in science on state assessments in grades 5, 8 and Biology
- Student performance on the high school U.S. History state assessment
- How well English Learners are making progress toward proficiency in the English language
- Student performance on the ACT or the ACT WorkKeys assessment
- Student participation and performance in accelerated courses, such as Advanced Placement (AP), International Baccalaureate (IB), and dual credit college courses
- Whether high school students are graduating on time

What is Not Captured in the Accountability Letter Grades?

- Grades do not measure how an individual student or teacher is performing.
- Grades do not take into consideration other things a school may be doing well, such as meeting students' emotional, social or health needs or how well students are performing in other subjects.



How are Accountability Grades Calculated?

Grades are calculated based on the number of points schools and districts earn in several categories, such as performance, growth, and the graduation rate (for high schools). Growth makes up more than half the grade for elementary schools and more than one third the grade for high schools and districts.
