I. Call to Order and Invocation

Heather Westerfield, Chair of the CSA, opened the Commission meeting and conducted a roll-call of the Commission members.

Ms. Westerfield announced that a quorum of the Commission existed.

II. Adoption of Agenda

VI. Discussion: Recommendation to revise Miss. Admin Code 7-3: 28.3, State Board Policy Part 3, Chapter 36, Rule 36.3: Access to Substantive and Rigorous Curriculum Policy, Process Standard 26 and Appendices A and B of the Mississippi Public Schools Accountability Standards, 2019

Dr. Dana Bullard, Office of Secondary Education, explained the need to revise the language to reflect current auditing practicing pertaining to the requirement for schools to offer advance level courses and to update the list of allowable courses.

X. Information: Proposed revisions to the Accreditation Policies of the State Board of Education in the Mississippi Public School Accountability Standards, 2019

Dr. Malone informed the Commission that MDE staff is currently working on some proposed revisions to the Accreditation Policies of the State Board of Education in the *Mississippi Public School Accountability Standards*, 2019 and the Commission would be receiving a copy of the proposed revisions in advance of a future meeting for their consideration. These proposed revisions will help clarify some of the language pertaining (but not limited to) the appeals and hearing processes for districts to appeal assignment of accreditation statuses and performance classifications, process for district notification of complaints received by the MDE, and updated language pertaining to Schools at Risk to align with the Every Student Succeeds Act (ESSA).
