OFFICE OF ACCREDITATION

- I. Information: Annual School Board Meeting Attendance Report in accordance with Miss. Code Ann. § 37-6-13

Background Information: According to Miss. Code Ann. § 37-6-13, the School Board Meeting Attendance Annual Report shall be submitted annually to the Mississippi Department of Education.

In accordance with Subsection (2) (a), if a member of a school board misses twenty percent (20%) or more of the meetings of the school board during a calendar year, except for absences caused by required military duty, the member must reimburse the school district that portion of the total salary paid to the member that year which is proportionate to the number of meetings missed by the member in relation to the total number of school board meetings held during that year. For purposes of this subsection, consideration may be given only to meetings of which public notice is required.

Before February 1 of each year, the president of each local school board shall submit a report to the State Board of Education containing the names of any members of the school board who missed twenty percent (20%) or more of the school board meetings during the preceding calendar year.
