DIVISION OF EDUCATOR PREPARATION

N. Approval of educator preparation programs as recommended by the Division of Educator Preparation

Background Information: In accordance with Miss. Code Ann. § 37-3-2 there is established within the MDE the Commission on Teacher and Administrator Education, Certification and Licensure and Development. It shall be the purpose and duty of the commission to make recommendations to the Mississippi Board of Education regarding standards for the certification and licensure and continuing professional development of those who teach or perform tasks of an educational nature in the public schools of Mississippi. Full documents pertaining to each request are available upon request. On May 6, 2022, the Commission on Teacher and Administrator Education, Certification, and Licensure and Development (Licensure Commission) granted approval of the following educator preparation programs as recommended by the Division of Educator Preparation:

Orientation, EDU 621 Assessing Student Learning, EDU 623 Technology in Education, EDU 628 Advanced Instructional Strategies, EDU 630 Engaging Student Learners, ETL 615 Principles of Linguistics and Modern Cultures; ETL 616 Exploring Language and Culture; ETL 617 Methods of Curriculum, Instruction, and Assessment; ETL 618 Intercultural Competence and Assessment; and ETL 619 Ethics, Advocacy, and Law, REA 617 Content Area Reading, and EDU 625 Instructional Leadership Skills in the Classroom.
