04.C. Action: Modify the grant award for the Mississippi Community Oriented Policing Services in Schools Grant (MCOPS) FY23 (2022-2023) [Goal 2 – MBE Strategic Plan]

Background and Purpose: The SBE awarded FY23 MCOPS awards to 14 districts in the total amount of \$570,000 on June 16, 2022. Seventeen additional proposals have been evaluated, scored and are eligible for funding.

Scope of Grant:

- Term of Current Grant: July 1, 2022- June 30, 2023  
(With a liquidation period ending July 12, 2023)
- Term of Modified Grant: July 1, 2022 – June 30, 2023
- Cost of Current Grant: \$ 570,000
- Modification Increase: \$ 680,000
- Total Cost of Modified Grant: \$1,250,000
- Method of Award: Request for Proposals

Funding Source: State Funds
