01. <u>Information: Spring 2024 Mississippi Academic Assessment Program (MAAP)</u>
3rd Grade Initial Reading Summative Assessment Results [Goals 1 and 2 – MBE Strategic Plan]

<u>Background Information:</u> The Literacy-Based Promotion Act's (LBPA) purpose to improve the reading skills of Kindergarten through Third Grade students enrolled in the public schools so that every student completing the Third Grade is able to read at or above grade level. (Miss. Code Ann. § 37-177-1 et seq.)

Students must receive a "Met Requirement" or score above the lowest two (2) achievement levels in reading on the established state-wide assessment. Levels will be assigned after the administration of the writing portion is added. Students must pass the 3rd grade Assessment or meet a Good Cause Exemption to pass to the 4th grade.

Met Requirements: A student who receives a "met requirements" designation on the initial administration meets the requirements of the LBPA for the 2023-2024 school year for promotion.

Did Not Meet Requirements: A student who scores "did not meet requirements" will need additional interventions and may participate in two additional retest opportunities: May 6-10 and June 17-28.

## **Initial Assessment Results Overview Explanation**

#### Overview

The Literacy-Based Promotion Act's (LBPA) purpose is to improve the reading skills of kindergarten through 3<sup>rd</sup> grade students enrolled in the public schools so that every student completing the 3<sup>rd</sup> grade is able to read at or above grade level. (Miss. Code Ann. § 37-177-1 et seq.)

Students must receive a "met requirements" or score above the lowest two (2) achievement levels in reading on the established state-wide assessment. Students must pass the 3<sup>rd</sup> grade assessment or meet a Good Cause Exemption to pass to the 4<sup>th</sup> grade.

### **Met Requirements:**

A student who receives a "met requirements" designation on the initial administration meets the requirements of the LBPA for promotion. Students who "met requirements" may still need supports in of the following areas:

- provide the main idea and supporting details, describe characters, and paraphrase literary texts;
- establish a purpose for reading;
- use structural analysis, describe multiple meanings of words, and interpret figurative language;
- describe characters and/or key details;
- recognize characters, themes, settings, plots, genre, points, and key details from texts (e.g., literary and informational texts);
- make connections to self, text, and the world;
- determine the author's purpose, literary elements, point of view in literary genres and informational texts;
- determine the author's point of view and their own point of view;
- apply vocabulary across content using structural analysis and context clues;
- recognize visual representations in informational texts; and,
- use root words, prefixes, and suffixes to change word meanings use reference material to determine meaning.

## **Did Not Meet Requirements:**

A student who scores "did not meet requirements" will require additional interventions and supports in the skills listed above. Students may also have a minimal understanding of the following skills:

- apply phonetic analysis to decode unknown words;
- determine story elements, the main idea, and cause/effect in literary and informational texts:
- respond to literal comprehension questions and summarize short story selections;

- demonstrate an understanding of a variety of informational resources by following written directions and using captions;
- identify characters, settings, plots, and genre (e.g., literary and informational texts);
- recognize the author's purpose;
- use context clues to determine word meaning within context;
- identify visual representations (illustrations) in informational texts;
- recognize root words, prefixes, and suffixes;
- use elements of phonetic analysis to decode unknown words;
- use sequencing, predicting, and retelling to understand literary and informational texts;
- use signs and labels;
- identify characters and settings (e.g., literary and informational texts); and,
- identify pictorial representations (illustrations) in informational texts.


