<u>Scope of Project</u>: NCIEA will provide the MDE with expertise for the purpose of facilitating and managing the Mississippi Technical Advisory Committee (TAC). The TAC provides guidance on technical assessment matters pertaining to validity, reliability, accuracy, and fairness for the Mississippi Statewide Assessment and Accountability Systems. NCIEA will also provide guidance and advice to the Accountability Task Force (ATF).

The contractor will provide the following:

- Hold three (3) meetings of the TAC per year to review submitted documents from assessment vendors.
- Provide direction, assistance, and evaluation of the work of the state's assessment vendors to ensure professionally accepted standards set forth by the U.S. Department of Education are met.
- Facilitate guidance to the AFT on technical issues related to the state's accountability system; make suggestions and provide feedback regarding any proposed changes to the Mississippi Statewide Accountability System.
- Assist with design decisions to ensure the assessment and accountability systems are technically defensible and reflect best practices in assessment standards.
