2.A. <u>Action: Award competitive grants for the McKinney-Vento Education for</u> <u>Homeless Children and Youth Program [Goals 1 and 2 – MBE Strategic Plan]</u>

<u>Purpose</u>: Grants are awarded to local educational agencies to ensure that homeless children, including preschoolers and youth, receive a free and appropriate public education and support services to eliminate barriers to academic success. Services will include, but are not limited to the provision of supplemental instruction, transportation, enriched education services, social services, and medical services.

Scope of Grant:

•	Grant Period:	December 1, 2017 – March 1, 2019 (with a liquidation period ending June 12, 2019)
•	Award Amount:	\$ 983,403
•	Method of Award:	Request for Proposals

Funding Source: Title IX, Part A of the Every Student Succeeds Act

All districts receive a base allocation to provide additional services to children who are homeless. The per pupil allocation is awarded to ensure that districts that serve more students receive a higher level of funding. The base allocation plus the per pupil allocation equals the total amount awarded per district.

Base allocation = \$27,316.75 Per Pupil Allocation = \$75.903288
