<u>Scope of Project</u>: The Every Student Succeeds Act (ESSA) requires that states report on the post-secondary enrollment of students in an annual report to the public. The purpose of this contract is to subscribe to the National Student Clearinghouse's StudentTracker database to provide student-level details reports, plus aggregated reports on the enrollment and academic achievements of students from the 236 high schools throughout Mississippi. The Mississippi Department of Education will disseminate these reports through SharePoint to each district.

The National Student Clearinghouse was certified as the only organization that provides a nationwide, central repository of information on the enrollment status and educational achievement of post-secondary students. The total compensation to be paid to the National Student Clearinghouse under this agreement shall not exceed the specified sum of \$118,800.00, as referenced in the attach quote.

The contract will be effective for three (3) years and shall be contingent upon the successful completion of the preceding year's contract and the availability of funds.
