03.B. Action: Contract to renew and expand services with Harris, Mackessey & Brennan (HMB), the vendor for the state's online application system (MCAPS) for grant programs administered by the Mississippi Department of Education [Goals 1, 2, 3, 4, 5, and 6 – MBE Strategic Plan]

<u>Scope of Project</u>: Mississippi Comprehensive Automated Performance-based System (MCAPS) is a web-based grants management system that is currently being utilized by all of the state's Local Education Agencies (LEAs), neglected and delinquent grantees, and several grant programs across the Mississippi Department of Education (MDE). The application reduces the administrative burden placed on LEAs when applying for grant funding, in addition to increasing transparency of grant activities to ensure funds are spent in accordance with federal and state guidelines.

The initial proposal five (5) years ago did not include all grant programs administered by the MDE. After various audits and USDE monitoring visits, it was determined that the MDE needed to centralize all grants into one system that would allow LEAs and other grantees to apply for funding, amend projects, and request reimbursements. Since this time, HMB has developed a monitoring component which will be beneficial with ensuring the alignment of plans and budgets to actual expenditures along with meeting the intents and purposes of all programs. Continued implementation of this platform will provide uniformity with the functionality and reporting across programs with SEA, LEA, and other grantee staff. In addition, the platform provides transparency by availing to the public the allocations, plan, budget, and request for reimbursement by grant program and grantee.
