03.C. Action: Award competitive grants for the Mississippi Community Oriented Policing Services in Schools (MCOPS) grant program [Goal 2 – MBE Strategic Plan]

<u>Background and Purpose:</u> Mississippi Code Ann. § 37-3-82 established the MCOPS for the utilization of School Resource Officers (SRO) within the K-12 education system. The law allocates a minimum of \$10,000 per school to pay the salary and benefits of School Resource Officers. The funding must be matched from local funds on a 50/50 matching basis.

• Award Amount: \$1,500,000

Method of Award: Request for Proposals

Funding Source: State
