



## Instructions for Collecting Racial and Ethnicity Data

- The sponsor should complete this form for each site under its jurisdiction each year. Sponsors of residential camps must collect this information for each camp session. For all other sites, the sponsor must count the participating children at least once during the site's operation.
- The sponsor's monitor or site supervisor will provide to each site, on a date determined by the sponsor, a form (*Summer Food Service Program Ethnicity/Race Data Collection for Parent/Guardian Completion*) to be completed voluntarily by the parent or guardian of participating children. The sponsor's staff member collects the completed forms and returns them to the sponsor's office. If a parent or guardian chooses to verbally identify a child's (children's) ethnicity and race, the site staff or monitor will complete the form on their behalf.
- Additionally, through written translations or sight translations, the sponsor will provide the form or the information on the form in a language that an individual with limited English proficiency can understand. The sponsor will provide the form in an alternate format that an individual with a disability can understand.
- The sponsor completes the form (*SFSP Site Ethnicity/Race Data Collection*) inputting the site data for each site and keeps it on file for the required time (current year plus three years).
- The sponsor completes the data regarding the number of children participating, the number of forms completed, and the number of unknown statuses for Ethnicity/Race categories.
- The table will be completed using the forms collected at the site, and if no forms, either school data or census data for this site. If there are forms for less than 50% of the participating children, the day of the free/reduced data collection, the sponsor will use aggregate data for the SFSP Site Ethnicity/Race Data Collection form, school data, or census data for the site location.
