Matters before the Subcommittee:

## I. Case of Antoine Bourne, Educator License No. 237037

Jennifer Nichols, legal advisor to the Commission Hearing Subcommittee, called the hearing to order at 9:10 a.m.

Attorney Ross requested a continuance for this matter. Jamie Creel made a motion to go into a closed session. Rebecca Gray seconded the motion, and the Commission Hearing Subcommittee unanimously voted to go into closed session. Jamie Creel made

a motion to go into executive session to discuss the request for continuance. Rebecca Gray seconded the motion, and the Commission Hearing Subcommittee unanimously voted to go into executive session. The following people remained in the room: Etta Taplin, Jamie Creel, Rebecca Gray and Jennifer Nichols.

During executive session, the Commission Hearing Subcommittee took the following action:

Jamie Creel moved that the Commission Hearing Subcommittee deny the request for continuance. Rebecca Gray seconded the motion, and the Commission Hearing Subcommittee unanimously voted to deny the continuance.

During Executive Session, the Commission Hearing Subcommittee took the following action:

Jamie Creel moved that the Commission Hearing Subcommittee suspend Mississippi Educator License No. 237037 issued to Antoine Bourne for a period of 8 years. Prior to petitioning for reinstatement, Mr. Bourne must complete two (2) three (3) credit hour in person classes on ethics and student-teacher relationships. Rebecca Gray seconded the motion, and the Commission Hearing Subcommittee unanimously approved the suspension of Respondent's license.

On a motion by Jamie Creel, seconded by Rebecca Gray, the Commission Hearing Subcommittee unanimously voted to come out of executive session.

In open session, counsel read the decision of the Commission Hearing Subcommittee to the participants.
