Matters before the Subcommittee:

### I. Case of Jesse Moore, Educator license No. 302581

Jonathan Dennis, legal advisor to the Commission Hearing Subcommittee, called the hearing to order at 9:17 a.m.

After all exhibits were received into evidence Jamie Creel made a motion to go into closed session to determine the need to go into executive session. The motion was seconded by Aaron Wilson and the Commission Hearing Subcommittee unanimously voted to go into closed session.
