

Mississippi Approved List of Dyslexia Screeners

2025-2030

Effective July 1, 2017, MS Code § 37-173-15 mandates that each local school district screen students for dyslexia in the spring of Kindergarten and the Fall of Grade 1 using a State Board of Education approved screener. The screener must contain the following components: Phonological Awareness, Phonemic Awareness, Alphabet Knowledge, Decoding skills, Encoding skills, and Rapid Naming. If the student fails the screener, the school is required to notify the parent or legal guardian of the results of the screener. **Data from the screener should be used with all other available data to design intervention and drive instruction.**
