Minutes of Mississippi Board of Education Meeting

October 17, 2024

The members of the Mississippi Board of Education met at 10:00 a.m. on Thursday, October 17, 2024, pursuant to Miss. Code Ann. § 25-41-5 for the purpose of conducting a regularly scheduled Board meeting.

The public accessed this meeting via livestream or in-person at the Central High School Building, 4th Floor Boardroom, 359 North West Street, Jackson, Mississippi. Board members physically present included: Mr. Glen V. East, Dr. Wendi Barrett, Mr. Bill Jacobs, Dr. Ronnie L. McGehee, Mr. Matt Miller, Mr. Mike Pruitt, and Ms. Mary Werner. Board members attending virtually: Mr. Matt Mayo (Carmel, Indiana) and Ms. Billye Jean Stroud (joined at 10:04 a.m. from New Albany, Mississippi). Student Representatives present: Ms. Kate Riddle and Mr. Crosby Parker. Dr. Lance Evans, State Superintendent, was also present.

- I. Mr. Glen V. East called the Board meeting to order at 10:00 a.m., after determining that a quorum of the Board existed for the purpose of conducting a meeting.
- II. Mr. Bill Jacobs led the Pledge of Allegiance and Mr. Matt Miller gave the Invocation.
- III. On a motion by Dr. Ronnie L. McGehee, seconded by Ms. Mary Werner, the Board unanimously approved the minutes of September 17, 2024 Board meeting.

 - Dr. Evans stated he met with Lt. Governor Delbert Hosemann to discuss some priorities for the upcoming Legislative session including chronic absenteeism, the teacher shortage, and district cell phone policies for students.
 - Dr. Evans stated he met with Rep. Willie Bailey and Rep. John Hines to discuss concerns with the Greenville School District.
 - Dr. Evans stated Rep. Sam Creekmore convened a meeting about student mental health support and district cell phone policies. Dr. Evans stated he,

Ms. Holly Spivey, Mr. Brian McGairty, Ms. Wendy Bailey from the Mississippi Department of Mental Health, Dr. Daniel Edney from the Mississippi State Department of Health, and a representative (Leah Smith) from the Lt. Governor's office attended the meeting.

- Dr. Evans stated he attended the Pass Christian School District Celebration. Dr. Evans stated that the A-rated district and for the first time all schools in the district earned an A rating.
- Dr. Evans stated the Principal Advisory Council meeting was held in Canton with 19 returning members and 23 new members.
- Dr. Evans stated the fall meetings in Clinton and Oxford were completed for the Teacher Advisory Council. Dr. Evans stated they had great conversations.
- Dr. Evans thanked Clinton and Oxford for hosting our meetings.
- Dr. Evans stated he, Ms. Holly Spivey, and Mr. John Ferrell visited Mississippi State's Advanced Composites Institute, Raspet Flight Lab, Research and Curriculum Unit, and Communiversity, which is a collaboration with East Mississippi Community College that aligns educational opportunities with industry needs.
- Dr. Evans stated he had the following speaking engagements:
 - Mississippi Council for Exceptional Children Conference: This event attracted 350 educators, which include nearly every special education administrator in Mississippi.
 - Stennis-Capitol Press Forum: Provided updates about Mississippi's progress in education and the work of the Accountability Task Force, answered several questions from reporters on the topics of school choice, and he thanked Dr. Ronnie L, McGehee for attending the event.
- Dr. Evans stated he attended the Center for Assessment 2024 Reidy Interactive Learning Series along with MDE's Accountability Team. Dr. Evans stated the series focused on: effectiveness and consequences of using standardized assessments for high-stakes decisions; strategies to improve decision-making processes to better align with desired outcomes and minimize unintended effects; and addressing educational inequities and promoting post-secondary readiness. Dr. Evans stated this was very beneficial and he received good information.

 - Mississippi Public Broadcasting (MPB);
 - National Assessment of Educational Progress, NAPE Ambassador Mike Ward, former State Superintendent of North Carolina;
