Background and Purpose: The purpose of the Nita M. Lowey 21st Century Community Learning Centers (CCLC) Program is to provide opportunities for academic enrichment activities during non-school hours or periods when school is not in session, such as before and after school or during summer recess, particularly for students who attend low-performing schools. The 21st CCLC Programs offer students a broad array of additional services, programs and activities that are designed to complement the regular academic program such as youth development activities, counseling programs, arts, music, physical fitness and wellness programs, financial literacy programs, environmental literacy programs, and career and technical programs. The 21st CCLC Programs also offer families opportunities for active and meaningful engagement in their child's education, including opportunities for literacy and related educational development.
