# Executive Summary

### **Pathway Description**

Family and Consumer Sciences (FCS) education in Mississippi consists of the CORE program and specific career and technical programs. The CORE program prepares students for living in the real world and helps them develop leadership, problem-solving, decision-making, criticalthinking, communication, computer, and mathematical skills. The specific career and technical programs focus on career exploration and gaining the skills in a specific profession for entrylevel employment or the continuation of education. FCS education enhances its students' leadership potential and essential life skills and encourages life-long learning.

### **Grade Level and Class Size Recommendations**

It is recommended that students enter this program as a 9<sup>th</sup> or 10<sup>th</sup> grader. Exceptions to this are a district-level decision based on class size, enrollment numbers, student maturity, and CTE delivery method. This is a hands-on, lab- or shop-based course. Therefore, a maximum of 15 students is recommended per class with only one class with the teacher at a time.

### **Student Prerequisites**

For students to experience success in the program, the following student prerequisites are suggested:

- 1. C or higher in English (the previous year)
- 2. C or higher in high school-level math (last course taken or the instructor can specify the level of math instruction needed)
- 3. Instructor approval and TABE reading score (eighth grade or higher)

- 1. TABE reading and math score (eighth grade or higher)
- 2. Instructor approval

# Course Outlines

### **Option 1—Four half-Carnegie Unit Courses**

This curriculum consists of four half-credit courses that should be completed in the following sequence:

- 1. Family Dynamics—Course Code: 20.0121
- 2. Nutrition and Wellness—Course Code: 20.0130
- 3. Child Development—Course Code: 20.0122
- 4. Resource Management—Course Code: 20.0129

### **Course Description: Family Dynamics**

Family Dynamics is a course that focuses on developing skills related to personal, family, and social issues. It includes instruction in dimensions of adolescent development, family decisions and responsibilities, social decisions and responsibilities, and management of family systems today. (Grades 9–12, 1 Semester, 0.5 Carnegie Unit)

#### **Course Description: Nutrition and Wellness**

Nutrition and Wellness is a course designed to help develop skills related to proper nutrition and the concept of overall wellness. It includes instruction in nutrition, exercise and diet, healthy food choices, meal preparation, and components for a healthy lifestyle. (Grades 9–12, 1 Semester, 0.5 Carnegie Unit)

#### **Course Description: Child Development**

Child Development is a course centered on developing skills related to physical, social, intellectual, and emotional development of the child. It includes instruction on considerations for parenthood, prenatal care, child growth and development, behavior management, the needs of exceptional children, and career opportunities. (Grades 9–12, 1 Semester, 0.5 Carnegie Unit)

#### **Course Description: Resource Management**

Resource Management is a course that addresses the identification and management of personal resources and family finances to meet the needs and wants of individuals and families throughout the family life cycle, considering a broad range of economic, social, cultural, technological, environmental, and maintenance factors. (Grades 9–12, 1 Semester, 0.5 Carnegie Unit)

# Career Pathway Outlook

### Overview

The Family and Consumer Sciences program presents careers related to family dynamics, nutrition and wellness, child development, and resource management. Students enrolled in this course will develop essential employability and leadership skills. Upon completion of this course, they will develop a professional resume and will have honed their interviewing skills. It prioritizes professional development, punctuality, and workplace behavioral etiquette. Some topics include pregnancy and childbirth, toddler development, meeting an exceptional child's needs, and developing strategic plans for misbehavior, family crises, and stress. Other topics explored are relationships and personal growth, basic first aid, safe work habits, nutritional quality, food safety, preparation and preservation, personal fitness, and physical and mental wellness. It teaches students how to implement intervention skills and enact preventive measures when supporting individuals who may be at risk of certain crises, such as child mistreatment, including budgeting, expenses, improving credit rating, and taxes. Also, ethical discussions involving identity protection and consumer rights are highlighted.

Workplaces that family and consumer science professionals may occupy include colleges and universities, government agencies, hospitals and healthcare settings, offices, private research groups, product manufacturers (conducting product testing or development), restaurants, schools, and community and social service agencies. A childcare professional, for example, may even care for children in a converted segment of their own home.

Most careers related to this program require at least a high school diploma, although careers with the highest earning potential—family and consumer sciences educators, registered dietitians, financial planners, marriage and family therapists, human development specialists, postsecondary teachers, and social workers, for example—require advanced degrees. Particularly, social workers develop critical thinking skills when utilizing math and general statistics in their careers. They will encounter topics including correlation, causation, sample sizes, selecting test groups, accuracy, and precision as they advance toward a college degree.

#### Needs of the Future Workforce

The U.S. Bureau of Labor and Statistics stated in 2021 that nearly 67% of workers with a family and consumer sciences (FCS) degree were employed in educational instruction and library occupations, management occupations, office and administrative support occupations, community and social service occupations, and business and financial operations occupations. Nationally, through 2032, some of the top twenty fastest-growing careers are nurse practitioners (45%), medical and health services managers (28%), physical therapist assistants (26%), occupational therapy assistants (24%), home health and personal care aides (22%), and personal care and service workers (21%). Also, in terms of growth rate, the top four FCS-specific occupational fields are: social workers (7%), registered nurses (6%), post-secondary teachers (4%), and managers (3%). Concerning job growth specific to social work, these consecutive fields involve child, family, and school social workers (16%), and all other social workers (9%). The largest employers of social workers are individual and family services, ambulatory healthcare

services, local or state government, and state, local or private hospitals. These professionals maintain case history records and prepare reports. They also interview clients both individually and in groups to assess their situational or capability needs. The patterns of job growth shown below in Table 1.1 are connected to a relevant range of occupations.
