G. <u>Approval to revise Miss. Admin. Code 7 – 4: Part 4: Licensure Guidelines K-12 to amend the Principles of Learning and Teaching Praxis Pedagogy Assessment requirement for educator license 211 Special Education/Birth to Kindergarten (Early Intervention) to align with the associated grade span (Has cleared the Administrative Procedures Act process without public comments)</u>

<u>Background Information</u>: On January 10, 2025, at its regular meeting the Commission on Teacher and Administrator Education, Certification and Licensure and Development granted approval of the Division of Educator Licensure's request to amend the current licensure pedagogy assessment requirement which serves as one criterion for obtaining the Special Education: Birth to Kindergarten (Early Intervention) (Endorsement Code 211) license type.

Particularly, the Division seeks to replace Praxis Principles of Learning and Teaching K-6 (Test Code 5622) with the most appropriate version of the assessment, Praxis Principles of Learning and Teaching (PLT) Pre-K – K (Test Code 5621). This amendment seeks to establish proper alignment to the most appropriate grade span associated with this licensure endorsement area. The Mississippi State Board of Education's "Discontinued Test and/or Adjusted Score Policy" will be used for transitioning from the current version of the PLT to the proposed replacement version. The proposed change will be effective September 1, 2025, in accordance with the Discontinued Test and/or Score Change Policy.

This item has cleared the Administrative Procedures Act process with no public comments received. The public comment period was open from February 20, 2025, through 5:00 p.m. April 3, 2025.

Discontinued Test/Adjusted Score Policy

Effective September 1 of the year that a new version of a Mississippi-approved assessment in the Mississippi Educator Licensure Assessment Program (MELAP) is implemented, passing scores from the most recently discontinued version of the assessment will be accepted for up to two (2) years from the date the assessment was discontinued. The most recently discontinued version of the assessment shall have been taken and passed on or before August 31 of the year the new version is implemented. An applicant for Mississippi educator licensure shall successfully complete current requirements of the MELAP if official test score results are no longer valid and reportable to the Mississippi Department of Education.

The chart below serves as an illustration of the assessment implementation process for a Mississippi-approved educator licensure assessment that is currently affected by the discontinued test policy. Official score reports shall be received in the Division of Educator Licensure via electronic score transmission directly from the administering testing company as applicable.
