H. <u>Award formula grants to school districts for the purpose of providing</u> reimbursement for 1-3 universal screening assessments

<u>Background:</u> State statute requires that the Mississippi Department of Education shall select early literacy and numeracy screening assessment instrument or instruments to be used throughout the state in the screening of students in Kindergarten through Grade 3. (Mississippi Code § 37-23-16; Mississippi Code § 37-177-5) The Mississippi Department of Education, in collaboration with Mississippi Reading Panel, has established an approved list of reading screeners to be used by local school districts in grades 1-3. Beginning in the 2024-2025 school year, the MDE has provided the Kindergarten Readiness Assessment three times a year for Pre-K and Kindergarten which will also serve as the screener.

<u>Purpose:</u> Contingent upon availability of funds, districts may be reimbursed on a per-pupil basis for the administration of screeners. To be reimbursed, districts must submit the 1-3 Reading Screener Selection Notification and Grant Application for Approved Screeners, as well as beginning-of-year, middle-of-year, and end-of-year data, in accordance with the established timeline and process.

Funds will be awarded based on the following methodology:

Per-pupil grant awards will be based upon enrollment in 1st to 3rd grade on October 1 of the prior school year.

<u>Funds available</u> = Per-Pupil Amount 1st to 3rd Enrollment

Per-Pupil Amount x 1^{st} -to- 3^{rd} -Grade Enrollment = Allocation
