- AE. Approval of the corrected industry certifications list that will calculate in the Acceleration component of Accountability Model for the 2025-2026 school year

Background Information: In March of 2025, AccelerateMS provided MDE the SWIB Certification list that included an error in the Manufacturing Cluster and Advanced Manufacturing Pathway. The certification list being presented today contains the necessary corrections. NCCER Core has been added back and will serve as the SWIB Certification for Advanced Manufacturing for the 2025-2026 school year.

Accountability Business Rule 9.2 states that the Acceleration component refers to the percentage of students taking and passing the assessment associated with the accelerated courses which include Advanced Placement (AP), International Baccalaureate (IB), Advanced International Certificate of Education (AICE) dual credit or SBE-approved industry certification courses.

The Mississippi Perkins V State Plan currently identifies industry certifications as a Measure of Program Quality for numerous career and technical education programs. These industry certifications will be administered through the Career and Technical Education Statewide Testing Program for the 2025-2026 school year for students who successfully participate in the corresponding program of study. The Office of Career, Technical, and Workforce Development Education is requesting approval for these 52 industry certifications to count in the calculations for Business Rule 9.2 for the 2025-2026 school year.

The 52 industry certifications have been researched and vetted to ensure alignment to the state approved program of study, approved curriculum, and current needs of business and industry. Additionally, the State Workforce Investment Board (SWIB) has reviewed and approved these industry certifications to ensure they meet the needs of business and industry and qualify for reimbursement in accordance with Miss. Code Ann. § 37-153-15.
