#### DIVISION OF EDUCATOR PREPARATION

AF. <u>Approval of Mississippi College's request to modify course titles and the approved course list for its licensure-track Media Arts (K-12) supplemental endorsement</u>

<u>Background Information</u>: In accordance with Miss. Code Ann. § 37-3-2 there is established within the MDE the Commission on Teacher and Administrator Education, Certification and Licensure and Development. It shall be the purpose and duty of the commission to make recommendations to the Mississippi Board of Education regarding standards for the certification and licensure and continuing professional development of those who teach or perform tasks of an educational nature in the public schools of Mississippi.

On May 2, 2025, at its regular meeting the Commission on Teacher and Administrator Education, Certification and Licensure and Development granted approval of Mississippi College's request to modify course titles, remove courses, and add courses to its approved Media Arts supplemental endorsement, licensure code 103. Due to the quickly changing field of study, some of the previously approved courses are no longer appropriate and should be replaced by more relevant courses. Candidates are required to take ART 205 and must choose six (6) courses out of seventeen (17) on the approved course list to earn the twenty-one (21) credit hours required for the Media Arts (K-12) supplemental endorsement. The request is as follows:
