### DIVISION OF EDUCATOR PREPARATION

U. <u>Approval of Mississippi State University's request to modify course titles, required courses, and equivalent coursework within its approved Mild/Moderate (K-8) supplemental endorsement</u>

<u>Background Information</u>: In accordance with Miss. Code Ann. § 37-3-2 there is established within the MDE the Commission on Teacher and Administrator Education, Certification and Licensure and Development. It shall be the purpose and duty of the commission to make recommendations to the Mississippi Board of Education regarding standards for the certification and licensure and continuing professional development of those who teach or perform tasks of an educational nature in the public schools of Mississippi.

On May 2, 2025, at its regular meeting the Commission on Teacher and Administrator Education, Certification and Licensure and Development granted approval to modify its approved supplemental endorsement in the area of Mild/Moderate Disability (K-8), licensure code 223 by updating seven (7) course titles, adding and removing one (1) graduate course, and by adding equivalent coursework at the graduate level to allow candidates to complete eighteen (18) hours of undergraduate level coursework and/or graduate level coursework as outlined herein. This supplemental endorsement shall only be added to an existing Elementary Education license and will require a qualifying score on the Foundations of Reading Assessment.
