06.B. <u>Action: Award renewability grants for the Nita M. Lowey 21st Century Community Learning Centers Program [Goals 1 and 2 – MBE Strategic Plan]</u>

<u>Background and Purpose</u>: Section 4204(j) of ESSA authorizes the Mississippi Department of Education (MDE) to renew grants awarded to eligible entities under ESSA, based on the eligible entity's performance during the preceding grant period, at the MDE's discretion. Under Section 312 of the Department of Education Appropriations Act, 2016, the provisions of ESSA apply to 21st Century Community Learning Centers (CCLC) Program grants awarded during the 2017-2018 school year and later years.

The Nita M. Lowey 21st Century Community Learning Centers (CCLC) program is designed to provide opportunities for academic enrichment activities during non-school hours or periods when school is not in session, such as before and after school or during summer recess, particularly for students who attend low-performing schools. The 21st CCLC programs offer students a broad array of additional services, programs and activities that are designed to complement the regular academic program such as youth development activities, counseling programs, arts, music, physical fitness and wellness programs, financial literacy programs, environmental literacy programs, and career and technical programs. Under ESSA, the 21st CCLC programs can renew up to additional five years or to the original terms of the grant.

Current 21st CCLC grantee that meets all criteria is eligible for renewability of award under the Title IV, Part B 21st Century Community Learning Center Program.

Scope of Grant:

• Grant Period: December 1, 2025 – November 30, 2029

(With a liquidation period ending February, 2030)

Award Amount: \$4,576,023.92

Method of Award: Requests for Renewability Application

<u>Funding Source</u>: Title IV, Part B, of the *Elementary and Secondary Education Act (ESEA)*, as amended by the *Every Student Succeeds Act of 2015*

Summary of Selection Process:
