04.A. Action: Contract with Guidesoft Inc., d/b/a Knowledge Services under the terms of the Master Consulting Services Agreement to provide for the acquisition of Information Technology Professionals [Goal 5 – MBE Strategic Plan]

Awarded Vendor: Guidesoft, Inc., d/b/a Knowledge Services  
Indianapolis, Indiana

Scope of Project: The Mississippi Department of Information Technology Services (ITS) and Guidesoft, d/b/a Knowledge Services entered into a contract, for a Managed Services Provider (MSP) Program that would provide for the acquisition of Information Technology Consulting Services.

Under the MSP Program, The Office of Technology and Strategic Services (OTSS) seek board approval for a new 5-year contract with Guidesoft for IT Professional positions. The new contract will allow the MDE to continue IT Professionals services for the maintenance and support of MSIS to include enhancements, bug-fixes, and addressing new requirements. The current contract will end on February 28, 2026, and work will commence under new Statement of Works (SOWs) with a new execution date of March 1, 2026, for the following positions. The total sum compensation to be paid under this contract shall not exceed the specified sum of \$22,000,000.
