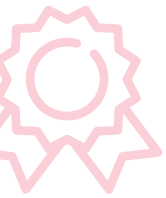
VISION



Any district with a grade of D or F shall establish a CEC.



Any school rated D or F shall establish a CEC.



Districts with several schools rated D or F may choose to have one district CEC instead of multiple school CECs.

CEC Reporting Requirements





Districts are accountable for setting up CECs and ensuring they meet regularly (MS Public School Accountability Standard 12).



Districts should submit all required evidence through the Mississippi Comprehensive Automated Performance-based System (MCAPS). Deadline to submit **June 30, 2025**





Planning for FY26 CEC Implementation

- Evaluate Needs
- Review Data and Set Goals
- Relationship building between new and veteran CEC members/chairs

- MDE recommends that established CECs meet at least six times per academic school year.
- The CEC should establish a meeting schedule at the beginning of the academic school year.
- All meetings should be open to the public.
- MDE recommends that meetings be between 60 – 90 minutes.

The independent panel of judges will use a scoring rubric to select two finalists.



The OSI staff will conduct a site visit to each of the finalist to learn more about their CECs.



The independent panel of judges will again review the finalists' application materials, as well as the site visit scoring rubric, to award.



Announcement will be made at the annual MDE School Improvement Conference 2025.

Community Engagement Councils (CECs), formerly referred to as P-16 Community Engagement Councils or P-16 Councils, are required under Miss. Code Ann. § 37-18-5. The purpose of CECs is to implement broad-spectrum community-based support for schools and districts implementing improvement plans to improve outcomes for learners.
