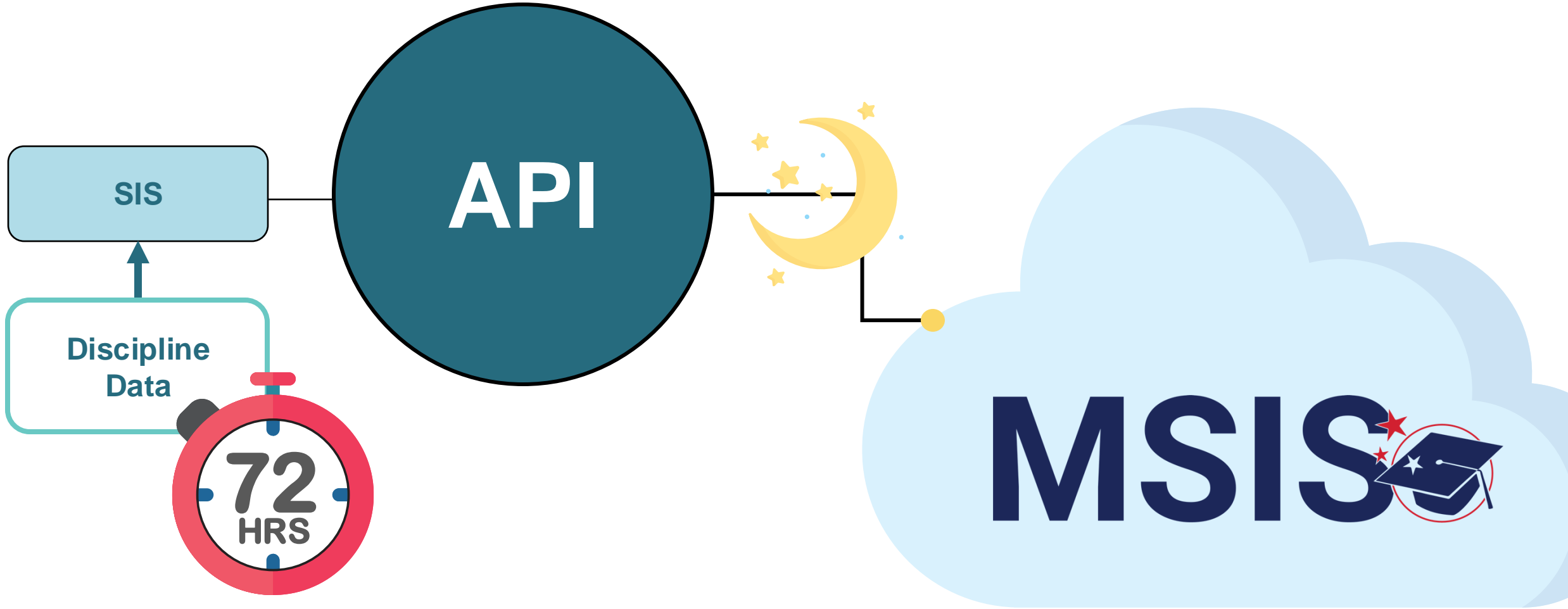

MS Code Ann. 37-15-6 (amended in 2013) references a **central reporting system for expulsions.**

The 72-hour reporting is believed to have been set as a reasonable time frame for reporting the expulsion of a student. If an expelled student from one district tries to transfer to another district, the receiving district could look in the “central reporting system” to know to contact the “exporting” district to see what the reason for the expulsion was related to the safety of the receiving school.
